In pursuance of guidelines No. P.33 (2)Home/Gr.9/2019 dated March 22, 2020 issued by Government of Rajasthan the company was completely lockdown & manufacturing activities of the company were stopped from March 23, 2020, followed by the guidelines of Government of India issued against the spread of CoVID-19 on March 24, 2020.
